## About The School

New Horizon School (NHS), an unaided Minority Institution, was established by World Education and Development Organisation (WEDO), with a purpose of producing excellent human beings with excellent academic standard clubbed with our cultural and religious knowledge.

The School is located amidst lush green and sprawling fields adjacent to Humayun's Tomb in Hazrat Nizamuddin. Our primary aim has been to impart modern education and to incorporate nationalist thinking based on Indian culture and Islamic traditions. There has been a conscious effort to bring our children close to diverse Indian culture through various activities, which enable them to appreciate and respect Indian culture as a whole and take pride in calling themselves a true Muslim and a proud Indian.



Our aim is to inculcate a strong sense of responsibility, both physical and moral, in order to build a value system based on quality education, whereby our students would feel confident in facing the complexities of the world which is fast shrinking to a small village due to the rapid globalisation. With a view to inculcate a strong bond between culture, religion and values of life we have made computer education mandatory for all classes starting from Class I itself.

Begun with 22 students and 2 teachers in 1978-79, the school has reached Senior Secondary level offering multiple streams and

wide choice of subjects. NHS has been producing one of the best results in Secondary and Senior Secondary classes ever since its inception. Urdu is compulsory for all students from Class I onwards. Being a co-ed institution, NHS encourages girl students for admission.

The school is fully equipped with all necessary infrastructure required of a modern school. There are two computer labs, one each for Junior and Senior sections. Computer education is compulsory from Class I onwards. At Senior Secondary level our students study computer as an optional subject. NHS is one of the pioneer schools in having initiated computer education. It is a must for all the faculties to be computer and internet savvy.

## Recognition/Registration

The World Education and Development Organisation is a registered body vide Registration no. 8911 of 1977 under Society Act XXI of 1860. The school has been accorded recognition by Directorate of Education vide No. F.Recog/Zone-19/D.S./88-Plg./795 dated 8/11/1988. The school is affiliated with CBSE vide CBSE/Aff/2730159/1998.

## Faculty

HORIZONITES are a competent team of teachers belonging to different castes, religions and states, selected strictly on the basis of merit. We try to maintain a ratio of 1 teacher for 22 students (1:22). The institution functions as a big family having well qualified and competent teaching staff, guiding and steering the students to attain dizzy heights and working as a cohesive team. All the members of the staff are approachable to the pupils as well as to the parents. There is a synchronised system for in-house training of teachers who undergo in-service and orientation courses at frequent intervals to keep pace with the rapid developments.



## Registration – Admission Procedure



1. The Registration form and Prospectus is available in the school during working hours on payment of the prescribed fee and can also be downloaded from the school website: [www.nhsdelhi.in](http://www.nhsdelhi.in), [www.nhsdelhi.com](http://www.nhsdelhi.com).
2. The birth certificate in original obtained from the respective corporation is necessary for admission up to Class 5th and for admission to Class 6th onwards, Transfer Certificate from the recognised previous school should be attached with the Registration Form.
3. Two latest passport size photographs of the candidate and parents should be submitted along with the Registration Form.
4. The age group of the students for admission to Class Pre-School and onwards as on 31st March of the progressive academic year should be 3+ and so on respectively.
5. A special provision for a modern well-equipped Pre-school class is available in the school for the students below 4 years of age. However, the school will have no obligation to take such students in the Pre-primary class.
6. Students from other schools can be given admission in class XI, in accordance to the eligibility criteria laid down by the school for each academic year.
7. For provisional admission to Class XI, Pre-Board result in case of Board based exam and the character certificate from the former school should be attached to the registration form.
8. Eligibility conditions for admission to class XI depends upon:
  - a. Candidate's standard appropriateness in the relevant subjects for the electives chosen by him/her.

- b. Existing Vacancy in the group of the electives chosen.
  - c. An overall assessment of the candidate based on the interview and the psychological test and on the candidate's past record.
  - d. **Students of class XI and XII would be considered as Day Scholars. Timings 7:00 am to 5:00 pm or as may be decided by the school authorities from time to time.**
9. Each of the electives available will be offered only when the minimum number of candidates for such elective subject will be available.

## Admission Procedure

1. No admission is allowed in Class X or XII, except where the candidate's academic record of the previous school will be found extraordinary at the school's sole discretion, and subject to the Board's approval.
2. A student who qualifies for admission to the school will be required to furnish the necessary certificates along with the undertaking wherever applicable and pay the prescribed fee for April, May and June and other charges within three days or within the stipulated time allowed by the School failing which the right of admission will cease.
3. Fee for the first quarter; April, May and June and other charges deposited at the time of admission (including provisional admission) will not be refunded in the event of the candidate's unwillingness to continue for any reason whatsoever. If the provisional admission is not approved by the Management the fee etc. will be refunded by cheque.
4. A student shall not be allowed to attend classes without completing all the admission formalities and without paying the prescribed fee and submitting the documents listed below:
  - a. Original and attested copy of Birth Certificate issued by the Municipal Corporation for Pre-School onwards.
  - b. Original School leaving certificate (for Class 6th onwards) duly counter signed by the District Inspector of Schools if the school is situated outside Delhi or by the Education Officer of the previous school if the school is situated in Delhi
  - c. Attested copy of the Progress Reports, i.e. Statement of Marks for the last three years.
  - d. An applicant seeking admission to Class X and XII hailing from a board other than CBSE will also be required to take written permission of the Chairman, CBSE.

## Withdrawal Procedure

1. If parents wish to withdraw their child from the school before the session begins and before the child has begun attending school, the fee for first quarter; i.e. April, May & June and other charges deposit at the time of admission (including provisional admission) will not be refunded, except for the security money. Same procedure will be followed in the case of provisional admission disapproved by the Management.
2. In other cases of withdrawal, three months' notice or three months' fee in lieu of such notice must be given.
3. Transfer Certificate is not given on withdrawal until all the school dues have been cleared.

## Attendance and Absence from School :

It is compulsory for all the students to attend the general assembly in the morning. The school gates will be closed five minutes after the school starts and students who come late will not be allowed to attend the school.



No child can leave the school premises during school hours except with the permission of the Principal, which will be granted only on receipt of an application duly signed by the parent and/or authorised person in the record of the school.

It is compulsory for students to attend the school on the first and the last day of the term or the vacation, failing which his/her name is liable to be struck off the rolls (parents to note carefully).

A minimum of 75% attendance is compulsory for all the students to appear in the final examination held at the end of the academic year.

No leave of absence is granted except on an application from parents and/or duly authorised guardian and/or person as per school record for plausible reasons only.

Repeated absence without sanctioned leave or unexplained absence for more than seven consecutive days will make the student liable to have his/her name struck off the rolls. Re-admission may be granted at the discretion of the Principal, on payment of prescribed re-admission fee and /or fine, if any.

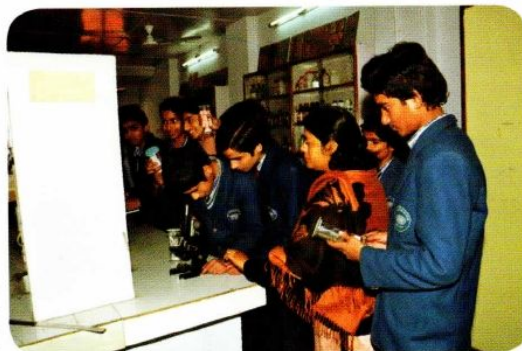
Each student is required to attend the school on the opening day after each vacation, failing which his/her name is liable to be struck off the roll and in case he/she is allowed re-admission at the sole discretion of the Principal. On the receipt of the application from the parents explaining the reasons for such default, they will be liable to pay fine @ ₹ 100/- per day plus re-admission fee.

Those absenting themselves on other school working days without advance leave application will be fined @ ₹ 25/- per day.

A student returning to school after suffering from an infectious or contagious disease or any sickness must produce a doctor's fitness certificate, permitting him/her to attend the school.

## Tests and Interviews

1. All the candidates seeking admission in various classes will be required to undergo written tests (except Pre-School and Pre-Primary). On the basis of the written test, the applicant along with parents may be called for an interaction. Seats will be offered according to the number of vacancies, purely at the discretion of the Management.
2. For admission to Class I and above (upto VIII), written tests will be conducted for English, Hindi, Urdu and Maths according to the prescribed school syllabus. The test papers for all the classes shall be of a duration of three hours.



## Termination

A student can be asked to leave the school, on any one of the following grounds. In such cases, the decision of the Principal will be final and binding on the concerned student and the parent.

- (a) Unsatisfactory progress in studies inspite of several warnings to the student and the parent.
- (b) Recurrent Indiscipline.
- (c) Behavioural problems detrimental to the class / school's atmosphere.
- (d) Detention in the same class for two consecutive years.
- (e) Being overage for any class.
- (f) Non-payment of fees as per given schedule.
- (g) Breach of moral code of conduct considered serious by the school.
- (h) Non-serious attitude and display of persistent negligence of school programmes, regulations and work ethics by the student.
- (i) Non-co-operation of parents in the welfare of the child, including their non-attendance in the Parent Teacher Meetings.
- (j) Any other matter considered serious and offensive by the School Management.



## Norms for Promotion

Child will be assessed on the basis of their performance in the tests, class and the home assignments. At the end of every term, examination will be conducted. The final assessment will be based on the overall performance in the unit tests and terminal examinations.

Promotion will be granted on the basis of the final assessment. A student who fails twice in the same class will not be permitted to continue his/her studies in the school.

## Parent-Teacher Meetings

The school has succeeded in developing active communication with parents through regular Parent-Teacher Meetings. **Such meetings are generally held on Saturdays, both before the terminal exams and after the terminal exams.**

These meetings provide an occasion for a meaningful interaction between Parents and the Teachers to discuss the progress of the child. A mutual and frank exchange of ideas between the parents and the teacher takes place and both together, try to formulate a common plan to help the child in his/her over-all development.

Generally, most of the parents visit the school on Parent-Teacher Meeting day. A serious view is taken of the absence of the parent/ guardian from these meetings. **Habitual avoidance of these meetings may become a cause of striking off the name of the child from the rolls.**

## Discipline



The school emphasises on inculcating and maintaining good discipline. The following guidelines must be followed in principle by all the students:

- (a) The students should always carry their school Identity Card and Bus Route Card.
- (b) It is expected from all the students to reach school at least 10 minutes before the school timings in the morning.
- (c) No student can leave the school premises during the school hours without the permission of the Principal, which will only be granted on receipt of an application duly signed by the parent, specifying a valid reason.
- (d) Students should always carry their school almanac, and produce it whenever asked to do so.

**Parents are expected to ensure that their wards are in proper, clean and properly ironed school uniform.**

**Use of school scarf by girl students to cover their head is COMPULSORY on Fridays and on the day of their Religious Teaching Period. It is also mandatory for Girls' Prefectorial Team to wear the school scarf in the school premises.**

**Note:** It is obligatory for the students to wear school uniform on PTMs when accompanying their parents.

## Fee Schedule

1. The fee becomes due in the beginning of the quarter (i.e. April, July, October & January) and is to be paid quarterly in advance, i.e. latest by the 10<sup>th</sup> of the month.
2. After the 10<sup>th</sup> of the month, if the fee is not paid, a fine of ₹ 5/- per day will be charged from the 11<sup>th</sup> to 15<sup>th</sup> of the month, from 16<sup>th</sup> of the month till the end of the month a fine of ₹ 10/- per day will be charged. Failure to pay by the last day of the month will entitle the school to strike off the name of the child and the child will not be allowed to attend the classes. Re-admission may be subject to availability of seat and on payment of full dues plus fine, if any and including re-admission charges of ₹ 200/-.
3. A child, who has outstanding dues for the session, will neither be allowed to take the final examination nor be considered for promotion to the next class.
4. A prescribed sum is to be deposited as security money at the time of the student's admission.



## Fee Concessions/ Free-Ship

Concession/ Free-ship of Tuition Fee may be granted to the economically and financially weak and meritorious students but from the next year after the admission. A formal written application on a prescribed form is to be made to the Principal giving therein complete and true statement of income of the parents/ guardians at the beginning of the session. Concessions will be withdrawn if the statement is found untrue or if the progress of the child is found unsatisfactory.



## Transport

1. Transport for carrying children on specified routes will be available on payment.
2. Transport expenses shall be payable for 11 months in each session.
3. A written application by the parents has to be made for any change of bus or bus stop. No telephonic calls and verbal communication will be entertained in this regard. Acceding to the request is at the sole discretion of the Principal.
4. Under no circumstances are the parents allowed to enter into any argument with the driver/conductor or teacher travelling in the bus. Any such instance will be sufficient cause for the withdrawal of bus facility besides inviting other disciplinary actions.
5. Hired Rickshaws and vans are strictly prohibited, especially on the routes where buses arranged by the school may be operating.
6. Once arrangement has been made for a student to use the school bus and the same is not required at some later stage, three months' notice must be given or in lieu thereof three months transport charges must be paid. Those parents who give notice that the bus will not be required after a certain period will not be allowed to use the school bus during the rest of the terms even if it is required again.
7. In case, the school transport is not available on the particular day due to the reasons beyond control, parents shall make their own arrangement to drop and pick up the children at their own cost.
8. Disciplinary action will be taken if a student is found using the school transport without paying transport fee.
9. The school shall not take any responsibility for any accident or mishap if it takes place during the period when the child travels in the school bus/vehicle or the bus/vehicle which is hired by the school for the transportation of the students. For security reasons the parents must make it a point to drop and pick up their ward from the bus stop. In case, somebody else is deputed by the parent to pick up their ward the school authorities must know about it and an authority letter with signature and photograph of the guardian/escort must be sent along with the guardian. The school authorities will in no way be held responsible, if these norms are not adhered to.
10. Children travelling by the School Bus must carry their bus pass daily with them duly signed, dated and should be shown/produced on demand.
11. Indisciplined behavior in the school bus will render a student ineligible to use the school transport in future.
12. Bus captains must help to maintain discipline and report any untoward incident to the transport in-charge the very next day. Those students not opting for school transport can use their own vehicle but will not be allowed to use any hired vehicle. Usage of rickshaw is strictly prohibited.

## Academic Programme

The medium of instruction is English throughout.

The school is divided into five distinct wings for its smooth functioning, namely:

### I. Senior Secondary School

For classes XI and XII, the subjects offered are: English Core, Mathematics, Physics, Chemistry, Biology, Computer Science, Economics, Business Studies, Accountancy, History, Political Science, Psychology, and Sociology.

## 2. Secondary School

Subjects taught at this level are English, Mathematics, Science, Social Science, Urdu, Music, Art Education and Physical Education.

## 3. Middle School

Subjects taught at this stage are English, Hindi, Urdu, Mathematics, Physics, Chemistry, Biology, Civics, History, Geography, Music, Art and Physical Education.

## 4. Primary School

The atmosphere in the Primary section is lively, more relaxed and informal than in the Senior school. The medium of instruction is English. English is taught along with the two other languages, i.e. Hindi and Urdu from Class I. Other subjects include Mathematics, Environmental Science (Social Science, General Science), Music, Art and Craft and Physical Education. Cultural activities and outings have a special significance and constitute an integral part of the year's programme.

Children are made familiar from the beginning to use the library and to enjoy reading books as there are a sizeable number of books for them in the library.

## 5. Pre-Primary School

This is the most important and crucial wing of the school because it is here that the child is initiated into a systematic and disciplined life. This section also works as a perpetual feeder for the school.

## Some Significant Features:

### R.T.M - 'Read To Me' Project/ Extra Marks Smart class

The school has witnessed a steady progress in the technology based teaching and infrastructural development. The **Extra marks Smart** Classes for classes VI-XII has proved to be a boon for the teachers and the students. The extra marks software has been uploaded in all the subjects (VI-XII). The **"Read to me" Project** for class III to VI has been initiated for enhancement of English Language Skills. The students now have the facility to listen and read the text on screen in their respective classes which has definitely boosted their confidence and has helped us to promote and raise the standard of communication skills in the school premises.

### Smart Class – A new change

New Horizon School, in its never ending effort to improve the teaching and learning process, has introduced the concept of **"Smart Classes"** for its students. **Smart Classes** integrate the traditional and the new technologically advanced methodology of teaching. A smart class comprises of a white board, LCD projector, speakers and a computer. The class room computer is connected to a high configuration server which stores bulk amount of study material in the form of animations, graphics, narrations and text. The HORIZONITES experience a new motivating way of learning with the aid of advanced technology which is helping them in improving their skills more efficiently and with less efforts. Initially 9 class rooms have been equipped with the technology for conducting these classes. Gradually every class room will be a smart class. To accomplish this task, the school has set up an advanced smart class lab and a very high speed LAN which is connected to these classes. Students of VI – XII are having their Smart Classes on a regular basis. Primary classes are also brought to the auditorium and activity room on regular basis to give them an exposure to Smart Classes before equipping the Primary section completely with the Smart class technology.



### School Family System (School as a Family)

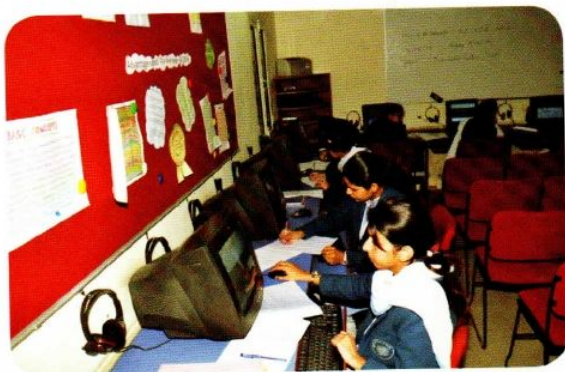
The school has a family system, "according to which each teacher is made guardian of a specified number of students. The student will remain under the guidance of the guardian teacher throughout his/her continuation in the school. The concerned teacher would look after the academic, emotional, physical and mental development of the children. Thus, the HORIZONITE will be in close contact with the teacher and will get extra care throughout the academic year.

## Faculty Meetings

One of the notable features of the school is the regular faculty meeting of various subjects. Teachers of each faculty get together with their HODs to discuss points arising out of the work of the previous week, new trends in education, problems of behaviour and education of children and to prepare records of pupils.

These meetings of subject-teachers aim at reviewing the work done and to co-ordinate the content, standard and the assignment given in different classes, both horizontally as well as vertically.

Workshops for teachers conducted by experts for in-service training and orientation programmes are regular features. Faculty meetings are a continuous, intangible input to furtherance of the professional growth of teachers.



## School Almanac

Every student of New Horizon School has to have a School Almanac. He/She must carry it to the school every day.

The diary must be checked every day by parents/guardian to see what assignments have been given, and whether there is any note or remark made by the teacher and then to be signed by the parents/guardian as a proof of having seen it. The diary must contain the full address of the child's home, his/her

parents/guardian specimen signatures, their telephone number, email and the student's blood group. Any change in the particulars mentioned should be immediately brought to the notice of the school.

## Languages Taught

Medium of instruction of all the subjects is English. Hindi and Urdu are taught along with English as compulsory subjects till the Middle Section with students enjoying the option of continuing with Urdu in class IX and X.

In seeking admission to any class a pupil should have adequate knowledge of all the three languages especially English. When Admission is granted in any class it will be the responsibility of the parents to see that the child who is weak in any subject especially English comes up steadily to the level of the class.

## Third Language Policy

In the school, children in all the classes have to study Urdu. It is taught from Class I onwards on compulsory basis.

## Physical Education

The school aims at the all-round development of its pupils. Consequently, proportionate emphasis is laid on the proper physical development of the child along with academic progress, emotional maturity and social well-being. As a result, sports and games form an integral part of the regular school time-table and our students play even at the National level.



## Medical Check-up

All the students have to go through medical checkups at regular intervals. New Horizon School also organizes detailed Medical checkups. An infirmary with necessary facilities exist in the school for First- Aid.

## Educational visits, Camps, Picnics and Tours

Teachers take their students for an outing, whenever possible. The location usually is a historical place, an interesting institution, an unusual site, a museum or the zoo.



Students are also taken for special visits to places which have a significant connection with the syllabus eg. planetarium, museum etc.

Children go for scout camping also. As and when tours are organized, students are encouraged to participate. The young ones go to nearby places, slightly elder pupils venture to places a little farther away. The senior ones go to distant places.

## Award System

In order to further improve the standard of academics and co-curricular activities, students need praise and encouragement. We give awards to the first, second and third rank holders in each class.

Awards are also given to the outstanding students, both girls and boys, in sports. Similarly, various prizes are given to meritorious performers in various competitions.

## House System

To spur a team spirit and the zeal to compete, the students are grouped under four houses. All houses are named after the National leaders i.e. Ambedkar House, Sir Syed House, Tagore House and Zakir Hussain House. These names serve as a source of inspiration for the younger generation.



## Books and Uniform

The school books and uniform may be bought from the authorized supplier of the school.

## What is required of N.H.S Students?

1. Must take utmost good care of their health and be strong and energetic.
2. Must always be friendly with other students, in and out of the school.
3. Vulgarity in talk and behaviour is strictly prohibited.
4. Must readily accept whatever extra-curricular work is assigned to them as and when necessary.
5. Must stand up when any teacher or elder comes to talk to them.
6. Always wish all elders especially all the teachers, in and out of school.
7. Always be a helping hand to their parents, brothers, sisters, junior students, teachers, their companions and even to senior students.
8. Must be truthful, whatever be the cost.





9. Must never cheat or be unfair at work or at play.
10. Must respect the liberty and the rights of others.
11. Must never be cruel. They should bear in mind that cruelty is the trait of a bully, while kindness is the mark of a gentleman.
12. Must respect the sanctity of the school premises and of their class rooms and report any damage they may observe.
13. Must look at people from all communities of the society as their brethren.

14. Must not waste their time in idle gossip.
15. Must take pride in wearing the school uniform.
16. Must carry their Identity Card.
17. Must never hesitate to say "No" when asked or tempted to do a thing which they know to be wrong.
18. Must accept their mistakes humbly. Be courageous to deny any false accusation but never be provocative.
19. Must express themselves freely, but with politeness.
20. Instead of lamenting or grumbling over the evils of the world, they must try to contribute their share in right earnest, to make this planet a better place to live in.
21. Must respect all religions and all religious places. This will induce respect for one's religion and religious place.
22. Always wish by saying "As-salam-o-Alaikum" to one and all. It is a prayer to "Allah" for the well being of others.



#### General Guidelines For Parents/ Guardians

- Parents must not enter class rooms either to see their wards or to seek interviews with the teachers during school hours or otherwise. They can meet the teachers or the Principal on P.T.M. days or by taking an appointment, through their ward's school almanac.
- When writing to the school on any matter, they should address it to the Principal and not to any person by name.
- They are required to co-operate with the school in its attempt to orient their child by paying attention to their regularity, punctuality and discipline and by taking interest in their child's work.
- They should check their ward's almanac every day, for the homework or for any other instruction given. They are also advised to check their ward's bag to see if any circular, invitation etc. has been issued and also discourage the child from carrying unwanted literature or items.
- They are required to inform the school if there be any change in their address/ telephone numbers, Bus route or email ID.

- 
- Leave for half day should be avoided, as far as possible, for security reasons. In any emergency, written permission must be taken from the Principal.
  - Children, when sick should not be sent to school, and qualified doctor should be consulted.
  - Attention is drawn to the fact that any criticism of a teacher or the school in the presence of their child causes the child, to lose his/ her respect for the teacher and will retard his/ her progress.
